Dear Sir/Madam;

The purpose of this letter is to inform you that all ingredients of the Stansfield's Fragrance Oils Limited C-Series liquid dyes fully comply with the following regulations and specifications;

- Europe Regulation (EC) No 1907/2006(REACH)
- RAL-GZ 041 revision September 2014
- IKEA IOS MAT-0049 version 6
- No Proposition 65 ingredients.
- No ingredients on the ECHA candidate list of Substances of Very High Concern (SVHC)
- No Nonlyphenol (NP) and Nonylphenol Ethoxylates (NPE) as ingredients
- No Bis-Phenol A (BPA)
- No Diacetyl as ingredients
- No Phthalates present as ingredients.
- No Nitromusks present as ingredients.
- No nut oils (including tree nuts).
- No dyes containing or that may release aromatic or aryl amines.
- No ozone depleting substances
- No Fluorochemicals
- No natural rubber latex
- No PVC
- No radioactive material
- No carcinogenic ingredients as defined by the list of carcinogens or reproductive toxicants published by NTP, IARC, or OSHA

All ingredients in Stansfield's Fragrance Oils Limited C-Series liquid dyes are classified as non-hazardous according to the directives in EU Regulation (EC) No 1272/2008 (CLP) and U.S. Sara 302/304/311/312.

The products mentioned above do not contain any of the prohibited Aromatic Amines listed in Annex XVII, appendix eight (8) of EU Regulation (EC) No 1907/2006(REACH) or Appendix A of IOS MAT-0049 version AA-44113-6. Stansfield's Fragrance Oils Limited does not use any phthalate esters, polycyclic aromatic hydrocarbons or ingredients that contain BTEX levels above those listed in RAL-GZ 041 revision September 2014 or IKEA IOS MAT-0049 version 6.

To the best of our knowledge these products do not contain heavy metals above the limits specified by RAL GZ 041 revision September 2014, IKEA IOS MAT-0049 version 6, RoHS, CONEG and European Toy Standard EN 71-2-1994. We do not intentionally add any heavy metals to the products
