#### 4.1. Description of first aid measures

#### 5.2. Special hazards arising from the substance or mixture

**HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE**

Do not breathe combustion products. The product is combustible and, when the powder is released into the air in sufficient concentrations and in the presence of a source of ignition, it can create explosive mixtures with air. Fires may start or get worse by leakage of the solid product from the container, when it reaches high temperatures or through contact with sources of ignition.

#### 5.3. Advice for firefighters

**GENERAL INFORMATION**

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Always wear full fire prevention gear. #### 6.1. Personal precautions, protective equipment and emergency procedures

If there are no contraindications, spray powder with water to prevent the formation of dust.  
Wear suitable protective equipment (including personal protective equipment referred to under Section 8 of the safety data sheet) to prevent any contamination of skin, eyes and personal clothing. These indications apply for both processing staff and those involved in emergency procedures.

#### 6.2. Environmental precautions

#### 6.3. Methods and material for containment and cleaning up
