

# UK Cosmetic Portal Guide

## V1 – Feb 2021

This guide only applies for the bath bomb CPSRs as supplied by Stansfield's . It is not appropriate for other products/product types.

Before you start make sure that you have:

- Formulation breakdown
- the name and details of a contact person for the National Poisons Information Service, or Trading Standards, to get in touch with
- who the 'responsible person' is
- An image of the product

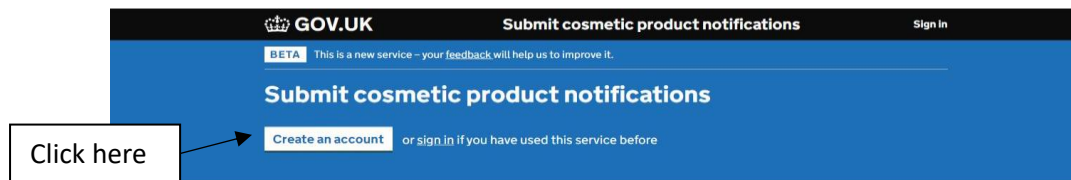
### PART 1 - SETUP

#### 1. Create an account

Click on the link below:


Notify the Office for Product Safety and Standards (OPSS) about cosmetic products available to consumers in Great Britain (GB).

#### What you need to do

You need to notify OPSS about every cosmetic product available to consumers in GB.

**!** You may face a fine and a prison term of up to 3 months if you do not notify OPSS about a cosmetic product. This fine could be unlimited in England and Wales or up to £5,000 in Scotland and Northern Ireland.

## Are you or your organisation a UK Responsible Person?

A Responsible Person may be the manufacturer, importer or distributor of the cosmetic product. They can also be a third party such as a specialist consultancy, as long as they've been given permission by the manufacturer or importer. The Responsible Person can be a company, limited liability partnership (LLP) or an individual. They must be based in the UK.

### Your cosmetic products

## 7. Multi-item kits

Select “No”.

### Multi-item kits

Multi-item kits have items that need to be mixed together or used in a particular order for them to work.

Examples of multi-item kits include:

- hair dye kits
- skin peeling kits
- permanent styling products
- anti-ageing or revitalising kits

Where a set contains separate products that do not need to be mixed together or used in a particular order for the product to work, you'll need to [submit a separate notification for each product](#).

## 8. Upload your image of your product label.

Upload an image/photo of the product label. This needs to be in the file format of PNG, JPG or PDF and will have to be 30MB or less in size.



## Upload an image of the product label

You must upload an image of the product label. You can also upload a photo of the product.

The images you provide must be in focus and all packaging text legible. If you are uploading multiple images, you must upload them all at the same time. You can upload up to 10 images. Each file can be up to 30MB and must be a JPG, PNG or PDF.

The product label and a photo of the product help the National Poisons Information Service identify the product.

The images you need to provide depend on the type of product and how it is packaged.

Carcinogenic, mutagenic or reprotoxic (CMR) substances can cause or promote cancers, cause genetic mutations or damage the reproductive process.

CMR substances are classified into 3 categories:

- 1A – known to be CMRs, based on human studies
- 1B – presumed to be CMRs, based on animal studies
- 2 – suspected to be CMRs, based on some human or animal studies
